# **CERTIFICATE IN PUBLIC HEALTH**

#### **Overview**

The Public Health Certificate Program is offered through the Graduate Programs in Public Health. The Public Health Certificate Program covers the core content of the Master of Public Health degree program in the areas of epidemiology, biostatistics, environmental health, administration and health education and behavior. The Public Health certificate program provides a foundation in public health training for interested students in other disciplines, and earned certificate credit may be used towards completion of the MPH or MSPH degree programs at the University of Miami.

The curriculum includes 5 courses (16 credits)

## **Admission Requirements**

In order to be considered for this post-baccalaureate certificate, you must be a U.S. citizen or permanent resident who holds an earned bachelor's degree.

• **Application** – Applicants must submit their application online through SOPHAS EXPRESS, the centralized application service of the Association of Schools and Programs of Public Health (ASPPH) (https://www.aspph.org/). Please note that the application and review process for the certificate program is separate from the regular graduate application process. Students admitted to the certificate program that later decide to complete an MPH or MSPH degree must submit a complete and full SOPHAS application and be considered by the Admissions Committee.

• **Transcripts** – Applicants must submit official transcripts from all previously attended colleges and universities. Upload scanned PDF files of your official documentation in the attachments section of the online application. Students who are admitted to the certificate program will be asked to supply official transcripts upon enrollment.

Standardized Test Scores – Certificate applicants are not required to submit Graduate Record Exam (GRE) exam scores.

• **Resume/Curriculum Vitae** – Applicants must include a detailed resume including employment, public health experiences, community service, research, and academic or professional honors. Prior public health experience is not required in order to be considered for acceptance.

• Statement of Purpose/Personal Statement – Applicants are required to submit a statement of purpose that details their academic interest in the program. The statement should discuss any experiences in public health including field experience, training, education or other related qualifications. Applicants should discuss how earning the certificate will contribute to their future professional and career goals, as well as to the future of public health. Applicants should also address any academic deficiencies, if applicable.

• Letters of Recommendation – Applicants must provide one letter of recommendation from an individual who is best able to assess their ability to be successful in a graduate degree program. Ideally, the recommender is a recent professor, researcher or employer in a related field. Letter should be signed and on letterhead. Applicants will be asked to include the contact information of their recommender on the SOPHAS application and the recommender will be sent an online form to complete via email.
